OUR MISSION

OUR ACCOMPLISHMENTS

This past year was filled with wonderful opportunities and many challenges. Some of the highlights were:

- (January) Held a Winter Symposium at Cathedral Square Conference Center. It was a sold-out special event for those with Parkinson's and their caregivers.
- (March) Co-Sponsored the movie "200 Perfect Jumps for Parkinson's Disease", a moving story of a son doing the extraordinary to raise awareness of his father's disease. Kevin Burkart from the movie appeared in person to talk prior to the movie showing and enhance the movie experience.
- (June) The 24th Annual Butcher Family Golf Scramble (sponsored by PAWM) was a successful fundraiser bringing in \$23,590.84 net income.
- (September) PAWM held a "Move-It" fundraising event at the Frederick Meijer Gardens to promote walking, exercise, and awareness of PD. We raised \$ 6,526.73 from the event.
- (4Q2016) Started to create a development plan for enhancing our website to allow for online donations. The new website projected to be released in Q4, CY2017.
- (4Q2016) Started the process of implementing Cloud-based QuickBooks for streamlined Accounting and complete transparency of bookkeeping procedures. It is scheduled to be released Q1, CY2017.


